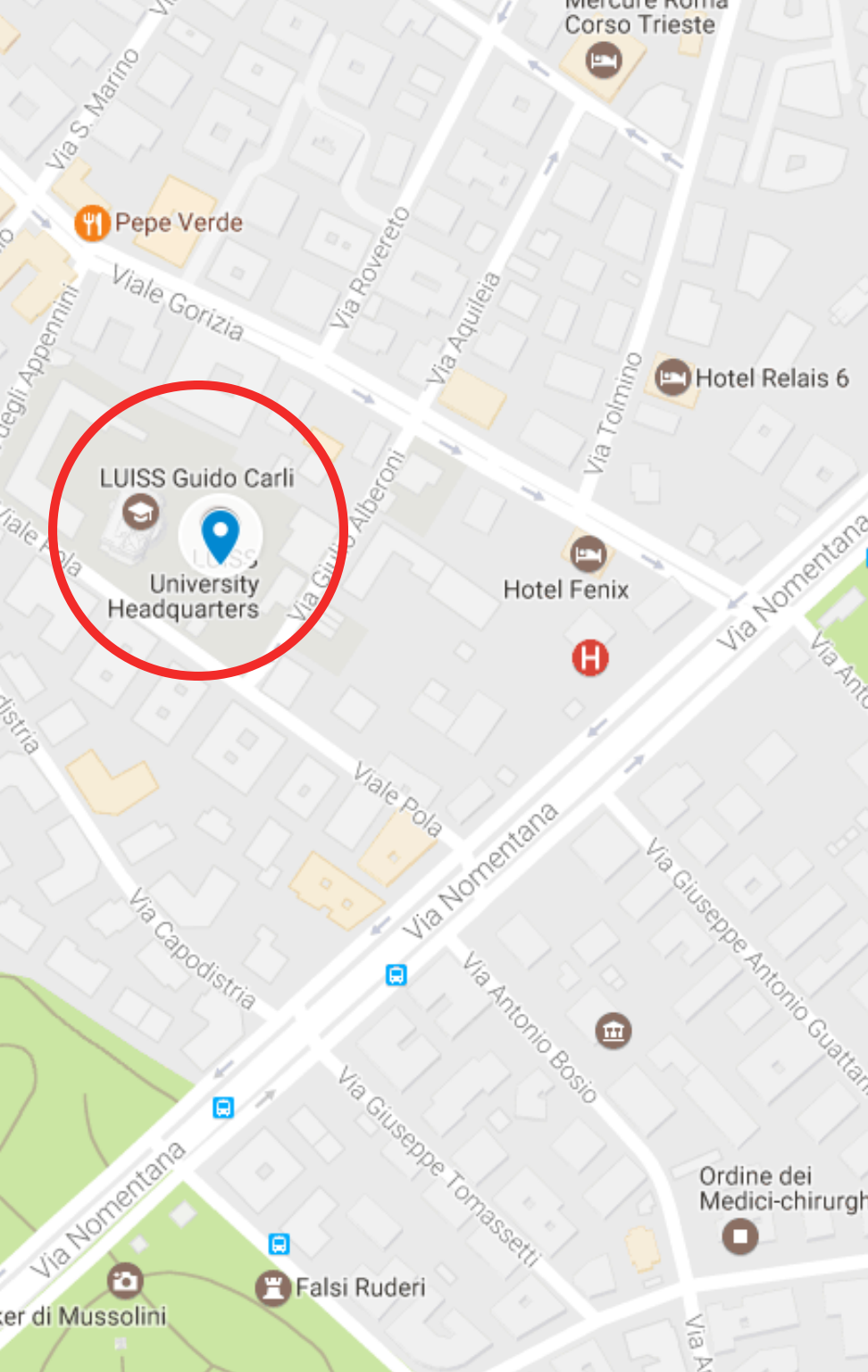

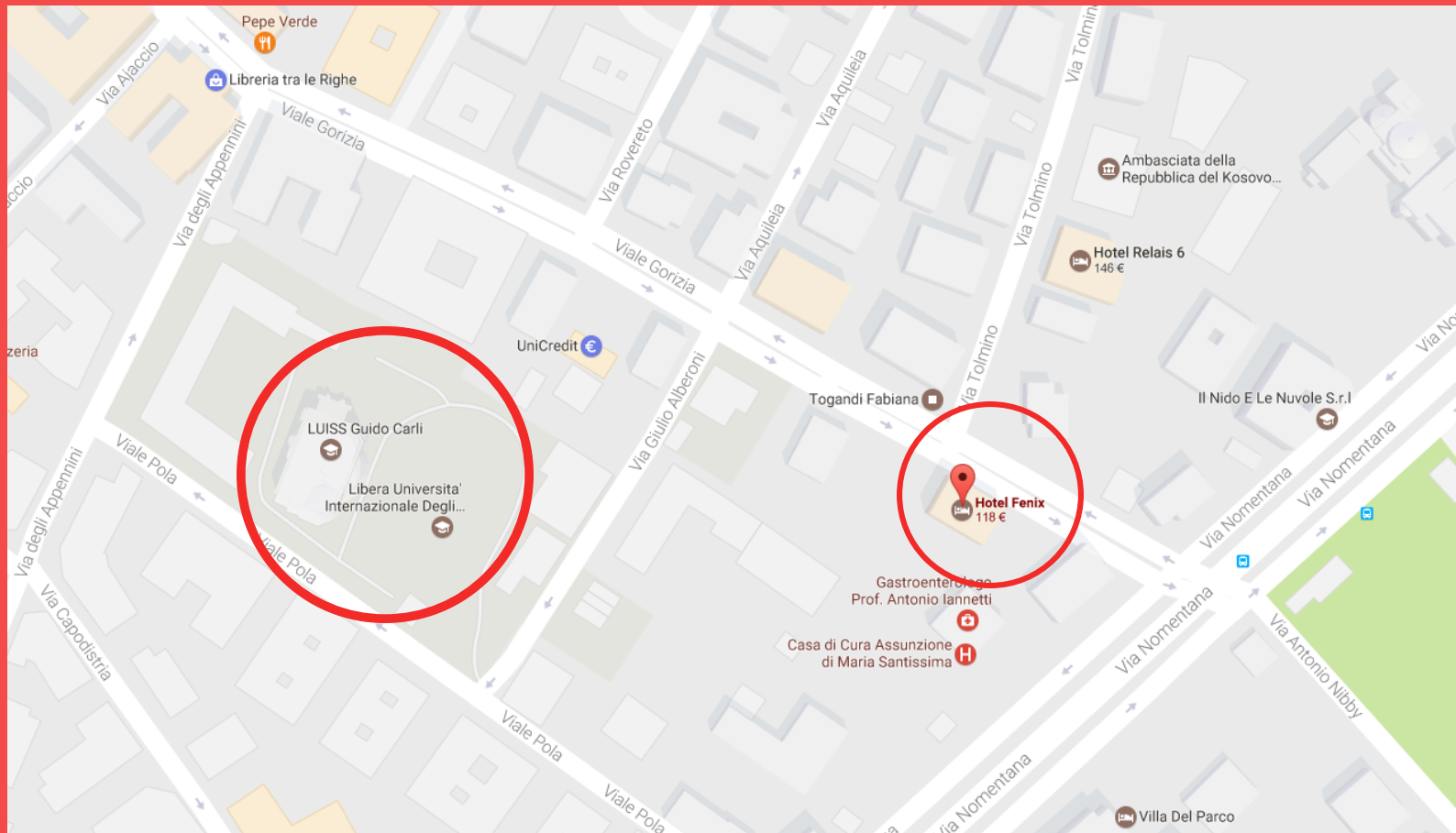

## GETTING HERE:

### **From Fiumicino airport to Stazione Termini**

A shuttle train called Fs non-stop Termini, leaving every 30 minutes links Fiumicino airport with Stazione Termini (ticket is about € 14).  
By taxi, the average fare from the airport is about € 55.00.

### **From Ciampino airport to Stazione Termini**

A bus called Atral, leaving every forty minutes links Ciampino airport to Anagnina (ticket € 1.20). The subway, METRO A, links Anagnina to Stazione Termini (ticket € 1.50)  
By taxi, the average fare from the airport is about € 45

### **From Stazione Termini to the venue**

Take bus n. 60L or 82 and get off at the stop Villa Torlonia/Nomentana. Continue walking for 200 m till LUISS main entrance in Viale Pola 12 .

By taxi, the average fare from Termini is about € 15.00/20.00
